

Rule Builder

Smart Weights

For student-based allocation models, *Allocate* will calculate smart weights for every school that correspond to student characteristics associated with district equity initiatives. This approach integrates student, grade, and school-level data to build funding weights and allocations that are closely matched with student need.



Hold Harmless Provisions

While changes to a funding formula can advance equity, some schools feel a loss in the process. The hold harmless provision sets guardrails to cap the year-to-year gain or loss in per-pupil allocations to each school. This provision helps districts take steps toward equitable resource allocation without dramatic funding decreases for any individual school.
